IV. PUBLIC HEARINGS

- A. Public hearing to consider adopting the 2022 Budget.

After the public hearing, City staff recommends approving the 2022 Budget as proposed in the updated budget summary at 54.550 mills which would be a reduction of .699 mills from the 2021 budget and a reduction of 3.699 mills from the budget published for the hearing. 54.550 mills would bring in \$2,599,982 ad valorem tax dollars as shown in the chart below. Additional details can be found in the 2022 Proposed Budget Summary.

V. ITEMS FOR COMMISSION ACTION

- A. Consider authorizing TranSystems to prepare and submit a KDOT Cost Share Program grant application to mill and overlay Sycamore from 10th Street to 21st Street.

On March 25, 2021 the City Commission authorized submitting a Kansas Department of Transportation (KDOT) Cost Share application for improvements to Sycamore Street from 10th to 21st. The City was not awarded that grant. However, the Fall round of cost share grant applications is open and we would like to resubmit this project for state fiscal year 2022/2023. The minimum City match did increase to 15%. The grant deadline is September 24, 2021.

4” mill, 2” overlay, new sidewalk ramps, addition of a 10’x5’ box culvert at Sycamore.

Staff believes we should resubmit this application for state fiscal year 2023, (July 1, 2022 – June 30, 2023).

- B. Consider authorizing bidding the Maple Street Reconstruction from 17th to the west City Limits; and the Maple Street Overlay from 17th to 10th Street.

The Kansas Department of Transportation (KDOT) Cost Share Project engineering is complete and has been reviewed by KDOT and is approved for bidding. For cost share projects, the City conducts the bid. Additionally, the Maple Street Overlay from 17th to 10th will be bid at the same time, and the bid documents will allow the contractor to provide an incentive for award of the overlay at the same time.

A suggested bid date of October 7, 2021 allows time for contractors to view the project and prepare the bid.

6. Discussion regarding the Southeast Liftstation and proposed path to move forward.


